



2017 CESifo Area Conference on Global Economy

Call for Papers

On **4 – 6 May 2017**, CESifo will hold its annual meeting for the Global Economy research area, intended to allow presentation of current research undertaken by its members and to stimulate interaction and co-operation between area members.

The 2017 conference will begin at noon on **Thursday 4 May 2017** and will run until **Saturday 6 May** (approximately 2pm). The keynote lectures will be delivered by **Costas Arkolakis (Yale)** and **Dave Donaldson (Stanford)**.

Moreover, this year, we celebrate the 200th anniversary of David Ricardo's Principles of Political Economy and Taxation, in which he, amongst other important contributions, laid out the theory of comparative advantage. To mark this occasion, on the morning of Friday 5 May 2017 the Ifo Institute and the German Economic Association invite all participants to a special session in which Sam Kortum (Yale), Douglas Irwin (Dartmouth), Peter Neary (Oxford), Daniel Bernhofen (American University), and Richard Baldwin (Geneva) will share their views on the historical and present time relevance of Ricardo's work.

Papers for the Area Conference can be submitted on any topic under the Global Economy field, covering trade, international finance, migration, global environmental issues, and others. Papers will be discussed in seminar format. Accepted papers will be published as CESifo Working Papers after revision.

The **deadline for submission** of complete papers, or 2-3 page abstracts, is **9 March 2017**. Preference will be given to complete papers. Papers for the conference can be submitted [here](#).

Authors of submitted papers will be notified no later than **20 March 2017** whether their paper has been accepted for the conference. CESifo will provide accommodation, and reimburse economy-class travel expenses for CESifo Research Fellows/Affiliates with accepted papers. A given paper is only allowed to be submitted to one of the CESifo area conferences. Papers which are more related to the topic of other area conferences will be re-directed to the respective area director.

Distinguished CESifo Affiliate - Call for Nominations

With the purpose of encouraging talented young scholars, CESifo has instituted the Distinguished CESifo Affiliate prize, to be awarded to the best paper presented by a young author at the CESifo Area Conference on Global Economy. Candidates will be accepted from close to completion of their PhD, to no more than five years after having completed it. The same limit applies to co-authors in the case of papers with multiple authors. The criteria for the award are scientific originality, policy relevance and quality of exposition. The winning paper will appear in the CESifo Working Paper Series and the prize winner will receive €3000.

All CESifo Research **Fellows** are welcome to nominate candidates for the award (it is not mandatory for candidates to be from the research network) by submitting the nominee's paper to Peter Egger (egger@kof.ethz.ch). **The deadline for nominations is 9 March 2017.**
