Employment and Social Protection

Munich, 20 - 21 April 2018

All CESifo research network members are invited to submit papers to the 2018 CESifo Area Conference on Employment and Social Protection. The purpose of the conference is to bring together the members of the CESifo Research Network to present and discuss their ongoing research, and to stimulate interaction and co-operation between them. The area has a wide scope of relevant research. It covers positive and normative research questions that are usually pursued in economic research on social policy, family policy and labor market policy. Further, it covers research questions that deal with inequality, redistribution and the political economy of redistribution and conflict.

SUBMISSION DETAILS

The deadline for submissions (complete papers or 2-3 page abstracts) is **8 February 2018**. Preference will be given to complete papers. Please note that online submissions only will be accepted. Papers may be submitted [here](#). Alternatively you may go to the conferences page on our website, and click on the conference name, which will lead you to the submission page. Please note that the same paper is allowed to be submitted to only one of the CESifo Area Conferences. Authors of submitted papers will be notified no later than 7 March 2018 as to whether their paper has been accepted for the conference. Papers which are more related to the topic of other Area Conferences may be re-directed to the respective Area Director.

CESIFO DISTINGUISHED YOUNG AFFILIATE AWARD

The Distinguished CESifo Affiliate prize, aimed at encouraging talented young scholars, will be awarded to the best paper presented by a young author at this conference. Candidates will be accepted from close to completion of their PhD, to no more than five years after having completed it. The same limit applies to co-authors in the case of papers with multiple authors. The criteria for the award are scientific originality, policy relevance and quality of exposition. **The winning paper will appear in the CESifo Working Paper Series and the prize winner will receive a €2000 prize.** All CESifo Research Fellows are welcome to nominate candidates for the award (please note that it is not mandatory for candidates to be from the research network). To nominate a candidate, a CESifo Research Fellow must submit the nominee's paper to Kai Konrad, Max Planck Institute for Tax Law and Public Finance (kai.konrad@tax.mpg.de) along with a brief letter explaining the motivation for the nomination. The deadline for nominations is 8 February 2018.

CONFERENCE DETAILS

CESifo will provide accommodation, and reimburse economy travel costs for CESifo Research Fellows/Affiliates with accepted papers. All papers presented at the conference will appear in the CESifo Working Paper Series. Other network members are invited to attend, but are expected to provide their own funding for travel and accommodation.
